### TSCP Harmful Sexual Behaviour task and finish group

In Summer 2021, a Multi-Agency Case Audit on Harmful Sexual Behaviour (HSB) was completed. From this a series of learning and recommendations were made, which resulted in the TSCP setting up a 12 month Task and Finish group to identify and roll-out a partnership wide HSB Assessment Tool. The group has representation from VCS organisations, Police, Primary and Secondary Schools, the Integrated Care Board, local NHS Trust, Torbay Council and others. There is an ambitious programme of work, but this Autumn, please look out for two things in particular.

The first is a new training package on offer via i-learn. The training provider is AIM and the courses will equip practitioners and safeguarding managers to work through and support, identify and work with harmful and problematic sexual behaviours. The training and checklist tool have been made available to the whole Torbay workforce, due to funding being provided by Devon Integrated Care Board and for the training from Safer Communities. It does mean a departure from the Brook Traffic Light Tool for some, but the AIM checklist is also based on the Hackett continuum model. Using the AIM checklist will bring consistency to where there are abusive or violent concerns, where an 'AIM 3' assessment may be completed by Youth Justice or MASH professionals. This means that there can be a confidence and assurance in where referrals may be necessary.

Secondly coming this Autumn will be a new policy and guidance document, which will be for all working within the TSCP and will support practitioners and managers alike. The task and finish group are keen to support your organisation and your professional practice to make a difference where these challenging issues arise.

# Graded Care Profile 2 is Coming to Torbay

### What is the Graded Care Profile 2?

GCP2 is an assessment tool that helps practitioners take a strengths-based approach to measuring the quality of care a child is receiving and supports them to identify neglect.

It can be used where neglect is suspected (assess the current quality of care and monitor progress after interventions) and where quality of care is of interest (targeting resources, understanding educational, emotional or behavioural outcomes for a child).

#### This is an update of the original Graded Care Profile and includes:

- more accessible language,
- obesity and online safety as areas,
- enhanced guidance to support the ease of use by practitioners and
- aligned to current legislative context.

All amendments have been tested with a focus group of practitioners followed by further testing for reliability and validity. Always met

### Who Can Use the Tool?

- Professionals involved in evaluating the care of a child.
- It can also be used by:
  - parents or carers who wish to evaluate their 0 care of a child themselves.
  - Young people who want to evaluate care that they receive from a parent or carer.

### **Position of Trust Loophole Closed**

#### Position of Trust Loophole Closed

We know it's illegal for teachers, care workers and youth justice workers to have sex with 16 or 17-year-olds in their care. However, are you aware a loophole in the law that means other adults who hold a position of power over a young person has now been closed?

The law has now been extended to include any adult who holds a position of power over 16 or 17-year-olds.

#### Why it has been changed

Those who carry out certain activities in a sport or religion are particularly influential over a child's development. For example, sports coaches have unique opportunities for physical contact, and can hold major influence over a young person's career and future development.

Similarly, those who carry out certain activities in a religious situation often have significant influence over a young person's spiritual and religious development, often against a background of emotional vulnerability or immaturity.

Both situations also have very high levels of trust, influence, power and authority and (particularly in the case of those involved in a religion) these figures are well established, trusted and respected in the community.

#### What has been done?

In Spring 2019 the Ministry of Justice conducted a review of the law in this area. This review found strong evidence for extending the law to cover situations involving activities taking place in a sport or in a religion.

This law (Sexual Offences Act 2003 (legislation.gov.uk) has been extended to include all adults in a position of trust

#### First Steps project

The First Steps project was started by professionals (doctors, therapists, and parents) in Torbay and Devon in October 21.

We aim to join up people around the child with developmental needs, and shift the focus from medical-focussed assessment towards child-centred support. The goal is to empower families and those working with them, to be able to understand, describe and support their child's needs right from the beginning.

#### In the last six months we have:

- created a handbook for families for primary and preschool children which SENDCos, family support workers and parent experts are using with families to start small peer support group workshops
- begun holding monthly multi-professional drop-ins for professionals working with children to access advice and discuss cases (anonymised)
- begun organising joint clinics for families of children under 5, with doctors/therapists and health visitors/preschool professionals

#### We are now working on:

- turning the handbook into an app for families for children of all ages, with the help of families
- signposting to practical needs-based workshops for families of children of all ages regardless of diagnosis
- training for professionals at all levels to be able to recognise and support neurodiversity using child-centred language ("First Steps Champion training")
- joint clinics for over 5s with doctors/therapists and school or early help professionals
